## 2024 Highlights

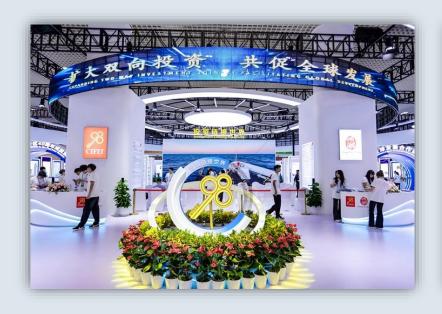
The event brought together representatives from 120 countries, 18 international organizations, 1,000+ agencies and business groups, and nearly 80,000 merchants to explore global investment and development strategies.

Agreements were reached on 688 projects during the conference, with a total planned investment of 488.92 billion yuan (\$68.74 billion).
